ImagePerfect™ 5902 Clearboard Film incorporates a high-gloss clear vinyl with an in-built polyester laminate that is suitable for use with whiteboard/dry-wipe markers. It has been specially created for use in transforming surfaces into dry-wipe surfaces and for recovering existing dry-wipe surfaces. The adhesive has a low initial bond to enable repositionability but builds over 24 hours to form a permanent, waterproof bond on most substrates. It can be cleaned with any dry-wipe eraser or IP Surface Cleaner.
