Attention: Please make sure the printed IP 2504 Pro is completely dry before laminating. Before the IP 2504 Pro is applied, the surface should be completely cleaned. The use of IP Surface Cleaner (MIP1000) and the lint-free, IP Surface Cleaning Cloths (MMS8373) is a good match-component cleaning solution to ensure that the surface is dry and free of dust and grease.
